2008 Smart Car Raffle
Official Rules

No More Homeless Pets KC is a not-for-profit organization organized under the laws of the State of Missouri. The following rules govern this raffle:

1. The purchase price of a single raffle ticket (effective 7/24/08) is \$25.00. Checks or money orders should be made payable to "NMHPKC". Payments are not tax deductible. If the bank dishonors an entrant's check, the entry ticket will be declared invalid unless full payment is received prior to the drawing. All tickets holders with tickets purchased at the previously published price of \$50.00, will be mailed a second ticket for each ticket purchased. These tickets will be mailed by August 10th, 2008.
2. Completed entries must be in the possession of NMHPKC, before 5:00 PM on September 13th, 2008 in order to be eligible for the 2008 Smart Car drawing. No more than 2000 tickets will be sold. Any tickets and payments turned in after the closure of the raffle will be returned to the entrants. All tickets will be recorded on a first come, first served basis.
3. Purchasers of raffle tickets must be licensed drivers over 18 years of age or older on or before September 13th, 2008. Anyone meeting this criteria is eligible to enter this raffle.
4. (Grand) Prize shall be a new 2008 Smart Car subject to these rules.
5. Names of all winners will be made available to the media, will be posted at the NMHPKC website, and in the NMHPKC newsletter.
6. Winning ticket will be determined by random drawing, by a neutral party. The Grand Prize drawing date will be held at the Smart Party on Saturday, September 13th, 2008 at Aristocrat Motors in the Jaguar Showroom located at 9400 W. 65th St., Merriam, KS 66203. Winners need not be present to win. Winners will be notified by telephone and mail.
7. The delivery of the vehicle would be made available to the winner as soon as reasonable; however, there may be a delay in delivery because of the availability of the vehicle. The winner is responsible for the transportation of the vehicle.
8. Winners will assume and be responsible for all licensing, registration, and all other fees, local, state and federal taxes, including and without limitation all applicable sales, use, withholding, luxury, income and special taxes. NMHPKC SPECIFICALLY DISCLAIMS ALL EXPRESSED OR IMPLIED WARRANTIES, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE REGARDING THE AUTOMOBILE.
9. If 500 tickets are not sold by September 1st, 2008 NMHPKC has the right to cancel the raffle and all payments will be returned.
10. More than one name may be stated on the ticket registration form; however, the first name listed shall be the "entrant." Payment or delivery of any prize will be made to the "entrant." The entrant must provide his/her social security number, if he/she is a winner. It is the sole responsibility of the entrant to allocate a winning prize to other participants in a multiple entry.
11. The decision of NMHPKC will be final in all matters pertaining to this raffle.
